

# PE Remuneration and FMV Project Instructions for the Public Consultation on the Global Principles



### Introduction

**This document will** provide you with all the necessary information and tools to contribute to the public consultation on the *Global Principles for remunerating the patient community for interactions with the pharmaceutical industry* in an efficient and effective way.

**The goal of the Public Consultation** is to establish an open and ongoing dialogue with key audiences to shape, socialize and disseminate the draft Global Principles throughout key organizations and networks.

It's key that all the relevant teams in your organization are engaged in the public consultation co-creation process. It is only through this broad consultation that the highest quality of deliverables can be achieved, ultimately leading to an overall higher impact for all stakeholders.

- Present the project and the Global Principles to your colleagues using the slide deck provided
- Collect feedback using the Public Consultation Feedback Report Template
- Provide your completed Feedback Report to <u>silvia@thesynergist.org</u> no later than Ist November 2021

The Public Consultation can also be contributed to on an individual level. If colleagues are not available to participate in your facilitated discussions, you can refer them to the <u>consultation survey</u>.

#### Who to target

For the success of this project and the public consultation, we encourage including the following audiences within your organizations:

- Pharmaceutical companies:
  - Heads of Compliance, Legal and Ethics functions
  - Functions with responsibility for the governance and oversight for remuneration of the patient community
  - Functions responsible for patient engagement and who manage relationships and interactions with the patient community and patient organizations across the medicine/drug lifecycle e.g. functions may be in research, development, public affairs, patient advocacy, etc.
  - For all the above, global, regional, and local/affiliate points of contact should be considered

#### - Patient Organizations/Networks:

- Patients, patient advocates, carers, patient organizations, and networks that are active in interacting and engaging with the pharmaceutical industry
- Patient community members that would benefit from being informed, educated, and engaged on the topic of remuneration and fair market value.



#### Template Email for inviting your colleagues

This template email may be helpful in reaching out to your colleagues to inform them about the Global Principles and the public consultation. Feel free to adapt it to your needs.

Earlier this year, Patient Focused Medicines Development (PFMD) kicked off a project focused on remuneration and fair market value for patient engagement, a continuation of collaborative work on the topic over the years. The project is focused on co-creating two main deliverables: the development of a globally recognized set of remuneration Principles, and a globally agreed-upon methodology for determining fair market value.

The PFMD project team and steering committee have launched a **Public Consultation** on the first deliverable: *Global Principles for remunerating the patient community for interactions with the pharmaceutical industry* (see attached). The Principles were co-created by harmonizing and building on previous work to ensure key values govern the remuneration process globally: transparency, fairness, equity, ethics.

We are invited to contribute to this consultation and submit our feedback on behalf of our organization. The Public Consultation is now open and we must submit our feedback no later than November 1st, 2021.

I suggest arranging a time for us to meet and review the global Principles as a team. The current draft of the Principles is attached and I kindly invite you to review it prior to our meeting.

#### **Background information about this project**

The aim of the Patient Engagement Remuneration and Fair Market Value project is to create and protect ethical, transparent, and fair interactions with patients. The project builds on previous collaborative work and is focused on two main aspects: the harmonization of a globally recognized set of Principles to ensure key values govern the remuneration process, and the co-development of a globally agreed-upon methodology consisting of a transparent, well-written, and documented process on how a fair market value is calculated. These can only be achieved through a comprehensive co-creation process involving key stakeholders and decision-makers.

Establishing a fair market value framework to fit a range of activities and contexts is an incredibly complicated endeavor. Co-creating a global solution with patients and industry partners will serve as an excellent baseline, significantly reducing the time and resources a single stakeholder would commit to achieving a similar goal. Moreover, reflecting PFMD's call to action – *Made with Patients* – the patient community is central in shaping the future of remuneration for engagement activities globally<sup>1</sup>.
