The PFMD Patient Engagement & Patient Experience Data Project: Why it is crucial to involve patients in PED processes.

Engaging the patient community in the generation and use of Patient Experience Data (PED) is critical for addressing unmet patient needs, facilitating evidence-based decision-making in healthcare, and driving improved health outcomes. The Patient Engagement (PE) & Patient Experience Data (PED) project is a global multistakeholder initiative, that aims to support the integration of PE and PED to generate more meaningful insights for healthcare decision-making. It is one project within Patient-Focused Medicines Development (PFMD) whose mission is to co-design the future of healthcare with patients, bringing together best practices and frameworks that involve patients as partners to enhance global health outcomes.

What is the PE & PED Integrated Navigator?

The PE & PED Integrated Navigator will be designed to assist stakeholders in selecting meaningful patient engagement activities for PED studies. Patient engagement should occur throughout all stages of PED research, and the PE & PED Integrated Navigator aims to provide a comprehensive guide to incorporating PE in the design, collection, analysis, and dissemination of a PED study. It will be co-created through international collaboration complimenting the existing [Global PED Navigator](#), which focuses on the what, how, when, why, and who behind PED.

- Provide customized guidance for meaningful patient engagement throughout PED studies.
- Enhance the relevance and impact of research outcomes by integrating patient perspectives.
- Facilitate more informed and actionable decision-making in healthcare research.

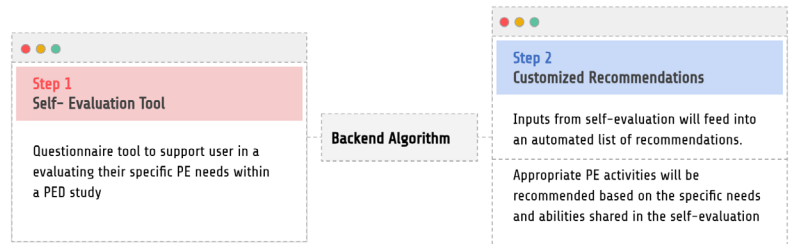

Structure of the PE & PED Integrated Navigator

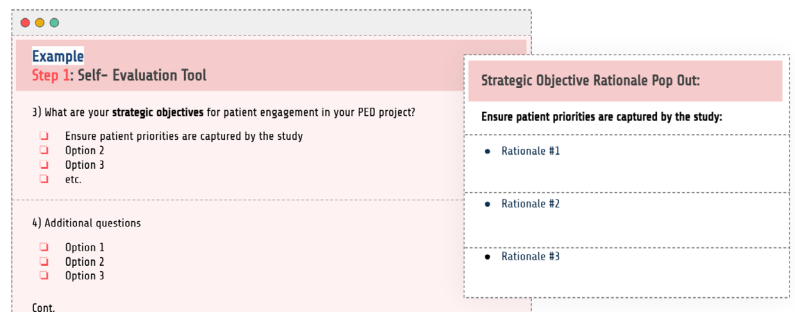
The PE & PED Integrated Navigator includes 2 Steps.

Please find the mockups below illustrating the structure and logic of the PE & PED Integrated Navigator.



Step 1 includes a self-evaluation tool (ie questionnaire) to identify the user's study considerations and PE experience level within a PED study. The questionnaire focuses on the following categories:

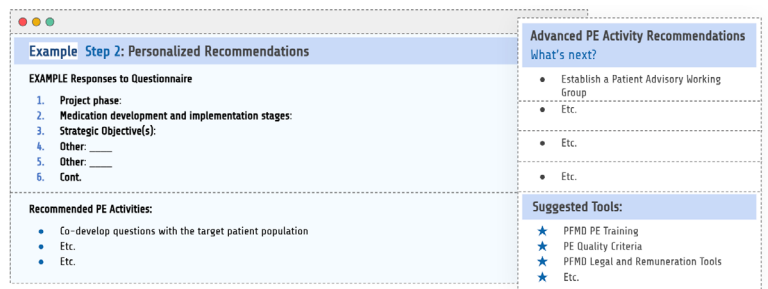
- Strategic Objectives for the PED Study
- Product Development
- PED Study Stage
- Disease Features
- Geographical Focus of Study
- Organizational Expertise
- Partner expertise



Step 2

Based on the responses to the self-evaluation tool, it includes customized recommendations for PE activities aligned with the user's study considerations and PE experience level.

It will also include suggestions for more advanced patient engagement activities and resources to help the user learn more about PE and strengthen their skill sets.
